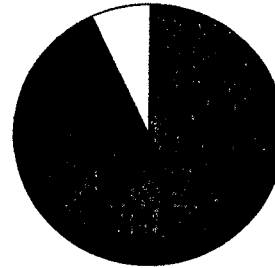

□ Short-term 7%

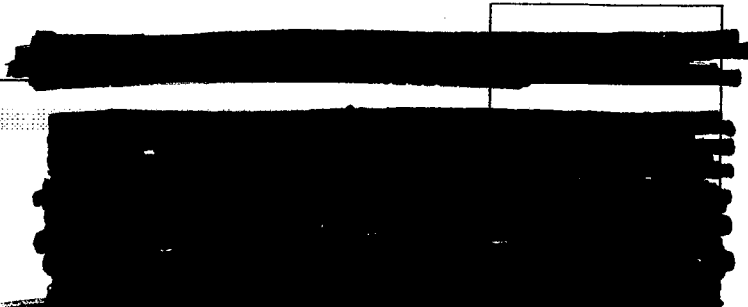
